**PRELIMINARY NOTIFICATION**

Whereas it appears to the District Collector, West Godavari District that the lands specified in the schedule below are situated in Linganaboinacherla (L.B.Cherla) village of Narsapur Mandal, West Godavari District needed for a public purpose, to wit, for Seshavaram New extension channel under Modernization of Godavari Western Delta System, notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of Section-11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act No. 30 of 2013).

There are no displaced families due to this Land Acquisition.

Now, therefore, in exercise of the powers conferred under Section-12 of the Act, the District Collector, West Godavari hereby, designates the Sub-Collector / Revenue Divisional Officer, Narsapur and her staff and workmen to exercise the powers conferred under the above said section.

Under section 11(4) of the Act, no person shall make any transaction or cause any transaction of land i.e., sale / purchase etc. or create any encumbrances on such land from the date of this notification without the prior approval of the Collector/R.D.O, Narsapur.

Objections to the acquisition, if any, may be filed by the person(s) interested within 60 (sixty) days from the date of publication of this Notification as provided under Section-15 of the Act before the Collector/Revenue Divisional Officer, Narsapur.
