

1. The vehicle shall be properly certified by the Road transport department.
2. The vehicles should be with valid RC.
3. The vehicles should have pollution free certificate.
4. Insurance to the vehicle up to date.
5. Valid license of the driver with taxi permit.
6. PAN/TAN certificate of service provider.
7. Vehicle should fitted with GPS device.
8. Other statutory documents required for hiring the vehicles to the Government use.

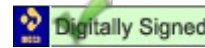


