PRELIMINARY NOTIFICATION

Whereas it appears to the District Collector, West Godavari, Eluru that the lands specified in the Schedule below are situated Tundurru Village of Bhimavaram Mandal, West Godavari District needed for Modernization of Gonteru Drain (42.800 to 47.600) notice to that effect is hereby given to all to whom it may concern in accordance with the provisions of Section 11 (1) of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act No.30 of 2013).

There are no displaced families due to this Land Acquisition.

Now, therefore in exercise of the powers conferred under section 12 of the Act, the District Collector, West Godavari, Eluru hereby designates the Revenue Divisional Officer, Narsapur his staff and workmen to exercise the powers conferred under the above said section.

Under Section 11 (4) of the Act, no person shall make any transaction or cause any transaction of the land i.e., sale / purchase etc., or create any encumbrances on such land from the date of this notification without the prior approval of the Revenue Divisional Officer, Narsapuram.

Objections to the acquisition, if any, may be filed by the person(s) interested within 60 (Sixty) days from the date of publication of this Notification as provided under Section-15 of the Act before the Revenue Divisional Officer, Narsapuram.
