1) **SOURCE OF FUNDS**

The funds for the work are provided by the Government of Andhra Pradesh Rural Development Department.

2) **ELIGIBILITY CRITERIA**

:

The Tenderer shall possess Technical and Financial experience of the Supplies made to Govt./Quasi Govt. Departments.

Posses Previous experience in Supply of **Procurement of Fruit bearing** and **Tall plants** to any Government Department.

3) CLARIFICATION OF TENDER DOCUMENTS:

Tenderers shall carefully examine the tender documents and fully acquaint themselves as all the conditions and matters which may in any way affect the work or its cost thereof. Should a Tenderer find discrepancies or omissions from the specifications or other documents or should be in doubt as to their meaning they should in advance address a query in writing to the Project Director ,DWMA & Addl. District Programme Coordinator, NREGS-AP, West Godavari, Eluru will entertain and offer clarifications to any such queries only if they are received well in time. Written copies of the Project Director, DWMA & Addl. District Programme Coordinator, NREGS-AP, Eluru response, including the description of the queries will be sent as an addendum to all Tenderers who have received the tender documents. Verbal information and clarifications given by any departmental Personnel shall not binding on the Department.

1) DOCUMENTS COMPRISING THE TENDER:

- 2) The tenderers shall submit his bid duly filled in.
- 3) The Demand draft for Earnest Money Deposit of Rs.1,00,000 (Rupees One Lakh only) drawn in favour of Project Director, DWMA & Addl. District Programme Coordinator, NREGS- AP, Eluru in any Nationalized Banks, should be submitted along with the Tender Schedule. Failure to enclose the EMD to the Tender Schedule will entitle to rejection of the Tender.

- 7) All the corrections, additions, erasers, over writing incorporated in the tender documents shall be initialed by the person or persons signed in the tender documents.
- 8) Tenderer shall prepare and submit the tender duly appending his signature on all pages.
- 9) AMMENDMENTS TO THE TENDER DOCUMENTS:
- 10) Two copies of such erratum will be sent to the Tenderers who have purchased the Tender documents and will be binding on them. The Tenderers shall sign and return one copy of erratum along with the tender which shall form part of the Tender.
- 11) To afford Tenderer reasonable time to take such erratum into consideration while preparing their Tenders, the Project Director, DWMA, Eluru at his discretion extend the deadline for the submission.
- 12) Any time prior to the dead line of submission of tenders, the Project Director, DWMA, Eluru may for any reason, whether at his own initiation or in response for the clarification requested by the Tenderer, modify the tender document by issuing a addendum/erratum.
- 13) **COST OF TENDERING**:
 - The Tenderer shall bear all the expenses associated with the preparation and submission of his tender and in no case, the Department will be responsible or liable for reimbursement of such expenses regard less of the conduct or out come of the tendering process.
- 14) The Tenderer should quote the cost each item.
- 15) In case of Discrepancy of Unit rate in figures and in words, the rate in words shall govern.
- 16) Tenders offered without quoting price for one or more items of the Schedule "A" will be rejected.
- 17) Rates quoted for all the items under Schedule-A shall include all taxes, duties surcharges etc., payable as per rules. No claims for additional amounts other than quoted will be accepted.
- 18) **EARNEST MONEY DEPOSIT:**
- 19) The Earnest Money Deposit should be enclosed as mentioned in the clause 6 above.
- 20) The Earnest Money Deposit paid by the Tenderer shall not earn any interest.
- 21 The Earnest Money Deposit paid by the Tenderers who have participated in Tender and are not successful will be returned after deciding the bid.
- The Earnest Money Deposit paid by the successful Tenderer will be retained as a part of Security deposit and further security deposit shall be paid at the time of Entering into agreement.

- 23) The Earnest Money Deposit shall be forfeited if a Tenderer modifies or withdraws at his own accord during the validity period of the tender.
- 24) The earnest Money Deposit shall be forfeited if a successful tenderer fails to supply the materials with in the specified time limit mentioned.
- 25) The Earnest Money Deposit shall be forfeited if the successful tenderer fails to remit the required balance security deposit as specified in above with in the specified time limit.
- 26) Only one tender shall be submitted by each Tenderer.
- 27) The Tenderer shall keep the signed documents and seal it appropriately before submission. Failure to take adequate precautions on the part of the Tenderer in submitting the tender as instructed above the Project Director, DWMA & Addl. District Programme Coordinator, NREGS-AP, Eluru will assume no responsibility for the contents of the tender The envelops should have the following details on the cover.

- 29) Name and address of the contractor should be mentioned clearly.
- 30) Tender shall be submitted in sealed cover addressed to the Project Director, DWMA, Eluru 31) The tender shall be deposited before the dead line prescribed in the allotted sealed box kept in the office of the Project Director DWMA West Godavari, Eluru
- 32) Tenders will be received in the office of the Project Director DWMA Eluru on or before **31.07.2019 up to 03.00P.M.**

The Project Director, DWMA, Eluru at his discretion, extend the deadline for submission of tenders by issuing an amendment in which case, all rights and obligations of the Project Director, DWMA, Eluru and Tenders previously subject to the original deadline shall be on thereafter to the subject to the new deadline as extended.

33) Any tenders received after expiry of the deadline prescribed in accordance of instructions to tenders shall not be considered.

34) **TENDER OPENING:**

The bids will be opened at **04.00 P.M. on 31.07.2019 in the O/o Joint Collector's Chamber at Collectorate,** Eluru.

35) TENDER PROCESS TO BE CONFIDENTIAL:

After opening of the tenders information relating to examination, classification, evaluation and comparison of tenders and recommendations considering the awarding of contract shall not be disclosed to the Tenderer or other persons not officially concerned such process until the award of the contracts to the successful Tenderer has been announced.

36) **CLARIFICATION OF TENDERS:**

For examination, evaluation and comparison of tenders, the Project Director, DWMA, Eluru may ask Tenderer individually for clarification of certain items of tenders including break up of unit rates.

The request for clarification and response shall be in writing. If Project Director, DWMA, Eluru, considers the rates of certain items of the lowest tender, which is under consideration are pitched high, he may ask the tenderer in writing to come for negotiations within the specified time and during the negotiations the tenderer may reduce the rates for the items and furnish the such modified rates in writing which will be final and binding on the contractor.

37) RESPONSIVENESS AND DETERMINATION OF TENDERS:

Prior to detailed evaluation of tenders, the Project Director, DWMA, Eluru, will determine each tender whether it is substantially responsible to the requirements of the tender documents. For the above purpose, substantially responsive tender is one which confirms to all the terms, conditions and specifications laid down in the tender documents without material deviation or reservation.

38) The Project Director, DWMA & Addl. District Programme Coordinator, MGNREGS-AP, Eluru reserves the right to reject any or all the tenders without assigning any reasons thereof. Not withstanding clauses above, the Project Director, DWMA, Eluru, reserves the right to accept or reject any tender and to annual the tendering process at any time prior to award of contract without thereby incurring any liability to the effected Tenderer or Tenderers on the grounds of Project Director, DWMA & Addl. District Programme Coordinator, MGNREGS-AP, Eluru's action.

39) **TENDER VALIDITY:**

- 40) The Tender shall remain valid and open for acceptance for a period of 90 days from the date of receipt of Tenders.
- 41) In exceptional circumstances prior to expiry of original tender validity, the Project Director, DWMA, Eluru, may seek the tenderer for extension of the validity for a specified period. The request and the response there to shall be in writing. The tenderer may refuse the request which does not warrant the forfeiture of the Earnest money deposit.

42) **EVALUATION AND COMPARISION OF TENDERS:**

The Financial bid offered by the tenderers who have been determined substantially responsive to the requirements of tender documents and found eligible in the Technical evaluation will be compared.

43) CONTRACT AWARD CRITERIA:

The Contract for the work will be awarded to the tenderer whose tender has been determined as eligible technically and substantially responsive to the tender document and who has offered the lowest evaluated tender price.

The tenderer shall have to produce the Sales Tax clearance Certificate & Income Tax Clearance Certificate before final payment. Prior to the expiry of Tender validity period prescribed, the Project Director, DWMA, Eluru, will notify the tenderer by Telegram or in writing that his tender has been accepted. The letter is here in after called 'Letter of Acceptance' and **shall name** the cost of contract. On furnishing of security deposit by the successful tenderer the names of the unsuccessful tenderers will be notified and their E.M.D. will be refunded.

45) **SIGNING OF AGREEMENT:**

At the time of notifying the successful tenderer, that his tender has been accepted work order will be placed duly specifying last date of supply. Failure on the part of successful tenderer to comply with the requirements will lead to forfeiture of the Earnest money Deposit.

- 46) A copy of the agreement entered into by the partners shall be submitted with the Tender. In case of successful tender, the form of agreement shall be signed so as to be legally binding on all partners of the Firm.
- 47) All the partners of the firm shall be liable jointly and severely for the execution of the contract in accordance of the contract terms and relevant statement of this effect shall be included in the authorization mentioned under Clause above as well as in the form of tender and agreement.
- 48) In all cases of personal injury to the worker employed by the contractor for this work for which contractor is liable to pay compensation under workmen's Compensation Act, shall pay the prescribed medical aid and Medical Officer for issue of C.D. Forms as prescribed. Failing which the said for will be paid to the Medical Officer by the department and recovery effected from the contractor's bills.

49) **PAYMENT:**

Payment will be made after submission of acknowledgements from responsible persons by the office of the Project Director, DWMA, Eluru.

50) In case of excess payment or wrong payment if any made to the tenderer/ contractor by mistake or due to the wrong interpretation of provisions, such additional payment will be deducted from the payments or other dues of contractor.

51) TIME FOR COMPLETION:

The plants should be completed in all respects within **15 days**.

52) **ARBITRATION:**

In case of any dispute or difference between the contractor and the department in execution of work or payment the matter will be dealt with as per the Arbitration & Conciliator Ordinance 1996 of the Gazette of India under "Arbitration and Conciliation Act 1996."

53) **LIQUIDATED DAMAGES:**

If for any reason the work is not completed by the period as covered in the agreement due to the reasons other than the department, liquid damage of 0.05% of the contract value shall be levied per day. The period for the above liquid damage commences from the date mentioned for completion of the contract in the agreement. However, the period allowed for completion of the work by the contractor for levying the liquid damages will be decided by the Collector & District Level committee, Eluru.
